Boise - Saturday, September 21, 2019, Family Advocates

- 1. Parking: Has accessible parking.
- 2. Entrance: Is accessible to people with disabilities, can accommodate wheelchairs/scooters, but the entrance doors do not open automatically.
- 3. Building space: Meets all requirements of the Americans with Disabilities Act. Training rooms will be on the second floor, which are accessible via the elevator.
- 4. Bathrooms: There are separate men's and women's bathrooms with individual stalls, the bathrooms are accessible and stalls are large enough for someone in a wheelchair to use.
- 5. Animals: Service, support, and companion animals are allowed

Coeur D'Alene - Saturday, September 29, 2019

- 1. Parking: Has multiple accessible parking spaces and a ramp transition between the parking lot and sidewalk leading to the entrance.
- 2. Entrance: Is accessible to people with disabilities, can accommodate wheelchairs/scooters and the entrance doors open automatically.

- 3. Building space: Hallways are wide enough to ensure people in wheelchairs can pass each other, there are no stairs needed to climb to arrive at training rooms, and the training space allows people to move through who use wheelchairs.
- 4. Bathrooms: There are separate men's and women's bathrooms with individual stalls, the bathrooms are accessible and stalls are large enough for someone in a wheelchair to use.
- 5. Animals: Service, support, and companion animals are allowed in the building with proof.

Moscow - Sunday, September 29, 2019

- 1. Parking: Has accessible parking and the parking lot is flat with a ramp that goes up to the entrance.
- 2. Entrance: Is accessible to people with disabilities, can accommodate wheelchairs/scooters and the entrance doors open automatically.
- 3. Building space: There are no stairs needed to climb to arrive at training rooms, and the training space allows people in wheelchairs to move through.
- 4. Bathrooms: There are separate men's and women's bathrooms with individual stalls, the bathrooms are accessible and stalls are large enough for someone in a wheelchair to use.

- 3. Building space: There are no stairs needed to climb to arrive at training rooms, and the training space allows people in wheelchairs to move through.
- 4. Bathrooms: There are separate men's and women's bathrooms with individual stalls, the bathrooms are accessible and stalls are large enough for someone in a wheelchair to use.
- 5. Animals: Service, support, and companion animals are allowed in the building with proof.
